Judging Criteria

- 1. For inclusion in this list individuals must reside predominantly in the UK and be of South Asian descent (i.e. those from Afghanistan, Bangladesh, Bhutan, India, Maldives, Mauritius, Nepal, Pakistan, Sri Lanka and their descendents or any genealogical combination of these).
- 2. Each individual was assigned a primary category e.g. investor. A second category has been assigned where the individual has more than one role e.g. entrepreneur and investor. The categories are Accelerator, Incubator, Investor, Digital Influencer, Entrepreneur, Technologist, Social Entrepreneur, Venture Capital.
- 3. Each individual's profile was developed based on:
 - their level of seniority and reach within their organisation for the purposes of this list I have only included CEO, CTO, CDO, CMO, COO or equivalent titles.
 - their impact this can either be based on number of ventures started, awards won, books and papers published, investment raised, exits achieved, people helped etc.
 - their level of innovation this is strength of their business idea or scope of their strategy or plan.
 - their level of influence this is a subjective criterion and would be determined by their public profile, social media followers, TED talks, podcasts, vodcasts, white papers, conference speeches, seminars hosted etc.
- 4. Individuals were then assessed from a longlist to a shortlist to a final list before being selected in the Top 5 categories of: Accelerators, Investors or Venture Capitalists grouped collectively as 'Investors', Digital Influencers and Technologists grouped collectively as 'Digital Influencers', Start-Ups, Social Entrepreneurs and Women.
- 5. Seven judges were asked to make their selections independently of each other with a casting vote by the Chair of the Judging Panel if required.
- 6. Judges were asked to declare any conflicts of interest and are excluded for consideration on the list.
- 7. The information for each individual has been compiled from published sources. Every possible effort has been made to ensure the information contained in this publication is accurate at the time of going to press. Celebrating the Top 100 Asian Stars in UK Tech

Digital industries are among the fastest growing in Britain, accounting for 1.46 million jobs last year with demand for skilled individuals growing at a rate of 28% year on year according to statistics in the Tech Nation 2015 report published earlier this year. But the success of industry in the UK has been marred by its lack of female and ethnic diversity at all levels.

So to challenge the notion of of the "white, young, male" stereotype, Diversity UK set itself a challenge to research the individuals working within the industry to see what it would find. Having spent the last 14 years publishing for the South Asian diaspora, my job was to start with a community I knew well. Imagine my surprise to quickly find over two hundred South Asian leading lights working in every corner of the British tech scene: from angel investing and startups, to fintech, cleantech, edtech, medtech and social enterprises.

Wayra's new StartUpDNA research has shown that the start-up system, in particular, is five times more likely to have individuals from ethnically diverse communities in C-Suite positions than FTSE 100 businesses. Furthermore, Wayra's research showed that 18.7% of people working in startups are from an ethnic minority background, the majority of them Asian. This affirms reports that Asians are more entrepreneurial than the average UK population and is a mirror image of what is now happening in Silicon Valley, as Asians steadily establish their global digital empires.

Those from the "old tech" corporate world of proprietary software solutions are embracing the "new tech" world of cloud-based SaaS services, cybersecurity, mobile applications and collaborative working. And it is not for themselves alone, many Asians mentor startups and social entrepreneurs; others contribute to online learning, creative collaboration, knowledge transfer and skills sharing or run hubs and entrepreneurial bootcamps.

Like all startup adventures, this list was joint collaboration with a stellar line-up of judges - Rob Chapman, Patrick Imbach, Shivvy Jervis, Neeta Patel, Sarah Turner and our Chair, Dilip Joshi MBE - to whom I owe a huge thank you.

My thanks also to the KPMG High Technology Growth Group team for sharing their knowledge of the latest developments on the UK Tech scene and for sponsoring the launch of this list, the 'Top 100 Asian Stars in UK Tech 2015'. Enjoy!

Over the last 3 years, Wayra UK & Wayra UnLtd start-ups have raised over to \$50m, with last year's cohort raising \$10.4m of that total before reaching demoDay, December 2014. To date, our companies have run 45 trials with Telefónica

UK, with companies like RotaGeek and Quidini being awarded contracts.

In 2015, Wayra UK welcomed 22 start-ups into its newly refurbished academy, half of which are being accelerated by Wayra UnLtd, the UK's first accelerator facility for digital technology social ventures. The social accelerator also tops the UK's Social Incubator Fund for third-party investment raised.




Adil Abrar Founder at Mastered

Adil Abrar is the Founder of Mastered.com, an online fashion school. Previously he founded, Sidekick Studios in 2009, a product design consultancy and incubator with \$2m+ annual revenues helping large organisations innovate like startups. Clients included RSA, Red Bull, Unilever, Sky, NHS London, Which?, Cancer Research, Charities Aid Foundation, Carers UK, and Flamingo International. In 2012, Adil was selected by The Observer as one of '50 New Radicals Making Britain a Better Place'. He is also the Co-Founder & Non-Executive Director of of VC-backed Buddy, an SMS and web app enabling people with anxiety and depression to take control of their own condition. Tushar Agarwal Co-Founder & CEO - Hubble



In August 2012, Agrawal launched Xendpay, an online money transfer platform aimed at remittance market, to cut down the cost of money transfer and bring more transparency in the market. Rajesh Agrawal was featured in The Sunday Times Rich List 2012 with a £90m fortune.



Ajaz Ahmed Co-Founder & CEO - AKQA

Ajaz Ahmed is the Co-Founder & CEO of AKQA, a digital agency that specializes in creating digital services and products. It employs 1,600 staff globally and was founded in 1994 in London by Ajaz Ahmed and James Hilton. In 2001, the company became AKQA Holdings Inc. after an investment of \$70 million by Francisco Partners and Accenture, with San Francisco as its new headquarters and four offices in the UK, US and Asia. In the same year, Nike Run London, a new branded sports format with 10,000 runners taking part was launched by AKQA for Nike. A year later, in 2002, Run London sold over 20,000 places in a few hours using an e-commerce platform designed by AKQA.

In 2005, AKQA Interface Design Practice helped Microsoft create the new user experience for the Xbox 360 gaming console. AKQA Mobile was launched as a specialist division in 2006. In 2010, AKQA created key branded iPhone apps launching that year: Gap Style Mixer, Nike True City, Nigella Quick Collection, and VW Real Racing GTI. In June 2012, AKQA joined WPP plc as an independent subsidiary within the world's largest communications group, with revenues of \$250 million that year. AKQA has garnered more than 100 industry awards, including at least one agency of the year award every year, and in 2014 it won Queen's Award for Enterprise: Innovation.

Ajaz and his co-author Stefan Olander, VP of Digital Sport at Nike crystallized their ideas of "the seven laws for a world gone digital" in 'Velocity', which featured a foreword by Sir Richard Branson and was published in 2012.

Ajaz Ahmed Founder - Legal365

Ajaz Ahmed is one of the original tech entrepreneurs who founded Freeserve, which was once the UK's largest Internet Company, in 1998. The eureka moment came when he bought a computer in PC World and nobody there could tell him how to get onto the Internet. After much persuasion, Dixons launched Freeserve in 1998, it became the UK's largest ISP in 3 months floated 9 months later with a market cap of £1.5bn. It entered the FTSE 100 soon after reaching a peak market cap of £9bn, Freeserve was sold by Dixons to France Telecom for £1.6bn in 2001. Ajaz left soon after the sale. He is currently the Founder of Legal365, a disruptive business model for the legal industry and runs his own business consultancy called SoSavvy. Ajaz also writes a column for Retail Week and sits on the Advisory Board at the University of Huddersfield Business School.





Ali Ahmed Founder & CEO - Lutebox

Ali Ahmed is Founder & CEO of Lutebox, an award winning London based startup that makes patented video communication technology. Winner of the Startup Games, Seedcamp finalists, and Lisbon Challenge finalists, Lutebox lets people voice chat over photos, and be more expressive and visual with their chats by putting a face to every message. The company has also developed patented technology for enterprise offerings in the social TV and social shopping spaces. An economics graduate from Lahore University of Management Sciences, Ali completed a Masters in Advanced Marketing Management from the University of Lancaster and started his career at Unilever working as an Assistant Brand Manager on the \$50 m brand, Brooke Bond Supreme. A stint at GroupOn UK & Ireland and a year spent consulting and advising startups like Tripster, spurred Ali to found Lutebox in 2011.



Azeem Azhar Evangelist - Brandwatch

Azeem Azhar is founder of PeerIndex, a startup building an expertise directory for the social Web, which was acquired by Brandwatch in 2014. Previously he worked with, started, advised or invested in startups like Seedcamp, Dopplr, Powerset, New Energy Finance, Zygo, TrueKnowledge, Mondus.com, PlanetOut, esouk and AMI Software. Prior to that he was Head of Innovation at Reuters; and had stints at the BBC, The Economist and The Guardian. He has a Masters degree in Politics, Philosophy and Economics from the University of Oxford.

Manoj Badale Co-Founder & Managing Partner - Blenheim Chalcot

Manoj Badale was born in Dhule, Maharashtra, India and later on moved to the UK. He is a graduate of the University of Cambridge where he studied economics. 
Suranga Chandratillake General Partner at Balderton Capital






Ajay Chowdhury Partner and Managing Director at BCG Digital Ventures




Nish Kukadia CEO - SecretSales.com






Uday Phadke Chief Executive, Cartezia

Salone Sehgal CEO & Director of Strategy - Truly Social



Rohan Silva Co-founder - Second Home



He has led global teams and built multiple businesses that have generated over \$750 million in sales, raised over \$230 million in funding, employed over 6,000 people and set up operations in 38 countries. Narry he started his career as a strategy consultant at The Mac Group (later Gemini Consulting); was the youngest equity partner at The Regis McKenna Group; and ran his own consulting firm for five years. He received a B.S. with Honors in Civil Engineering from Punjab University in India, a graduate degree in Civil Engineering and Management from Stanford University, and conducted graduate research at Massachusetts Institute of Technology.

In 2014, he became the inaugural Chairman and founder member of the UK Sharing Coalition - a body dedicated to making the UK the best place in the world to share.



Raj Sivalingam - Executive Director, Telecoms & UK Spectrum Policy Forum - Tech UK

Raj Sivalingam is the Executive Director for Telecoms and Spectrum at TechUK, an organisation involves the leadership of activities in support of telecommunications-based companies. Raj's responsibilities include negotiating and influencing government and regulatory policy, knowledge sharing (across industry) and thought leadership, and enabling market development (ie. tackling business issues and barriers). Having studied economics at Cambridge, Anil worked in private equity for Lehman Brothers and Cogent Partners for five years during which time he spoke to hundreds of business owners and came to understand the financial constraints they faced. Along with friends from his time at Cambridge he hit upon the idea of helping businesses access finance by selling individual invoices direct to investors to raise funding. He quit his job in 2010 and MarketInvoice began trading in 2011. In 2012, Anil was named as one of Forbes Magazine's 30 under 30 entrepreneurs and has won numerous business awards.
